VICTORIA TARGET THEATRE SOCIETY SUSTAINING CO-SPONSORSHIPS

It costs just over \$1,000 to prepare, rehearse, and present a Target play. A small portion of this cost is covered by grants-in-aid. This leaves the vast majority of the cost of each performance to be covered by Target memberships, performance fees, and individual sponsorships and donations.

Because most community organizations are able to afford no more than \$250 to bring in a Target performance, Target needs to ask individuals and organizations in the community to help support the good work of Target by co-sponsoring community performances.

You can become a sustaining co-sponsor for Target by pledging \$250 per year. Your yearly co-sponsorship donation of \$250 will enable Target to provide one community performance in each year in which you donate.

Any multiple of \$250 is welcome. If, for instance, you are able to afford an annual co-sponsorship donation of \$500, your donation would sponsor two Target performances each year. \$750 would sponsor three performances.

Target Sustaining Co-Sponsors are acknowledged on the Target website (www.targettheatre.ca) and brochure and in the programme for the performance which is made possible by their co-sponsorship donation.
